

Accessibility statement'

Buda Health Center Zrt. is committed to making its website accessible, in accordance with the Act LXXV of 2018 on the accessibility of the websites and mobile applications of public sector bodies.

This accessibility statement applies to the [OGK.hu](https://ogk.hu) website.

Compliance status

This website is partially compliant with the Act LXXV of 2018 on the accessibility of the websites and mobile applications of public sector bodies, due to the non-compliances listed below.

Non-accessible content:

Non-compliance with the Act LXXV of 2018

1. When using the keyboard for navigating in the main menu of the pages examined, the user cannot decide on opening or closing submenus, as the activation of main menus by using the keyboard triggers a new page to be loaded, thus, due to the automatic opening of submenus, in order to navigate between any two of the main menus by using a keyboard, the key focus has to go through all of the submenus that stand between the two main menus. On the pages examined, it has to be indicated visually in desktop view as well, which of the main menus have submenus. In the mobile view of the pages examined, the arrow icon for opening a submenu appears next to the "Contact information" main menu as well, even though no submenu belongs to the "Contact information" main menu.
2. Submenus cannot be opened still with the use of a screen reader software. The screen reader software's cursor moved to the menu with the arrow keys, followed by a press on Enter or Space at a main menu, the submenu appears and at the same time the page instantly reloads and navigates away.
3. Jump links for positioning the key focus on the main region and the footer cannot be found in the header of the website. Jump links have to be installed in a way that they stand among the first four elements of the tab order, appear visually when having focus on them, and when activated, the key focus also moves to the marked segment attributes. Example: None of the examined pages of the website have jump links.
4. After the submission of the form at the „Newsletter" page, if it is filled out incorrectly or incompletely, out of the many different error messages appearing at the same time, only the first error message is read out loud at the time of its appearance.

Disproportionate burden

In order to meet the modification requirements, the whole website should be remodelled and redesigned necessarily, which would demand a disproportionate excess development.

Preparation of the accessibility statement

This statement was prepared on *1st June 2022*, based on the self-assessment performed by the Company.
